### **Research Interests**

The overarching objective of my program of research is to inform national health policy by conducting studies aimed at evaluating the influence of regional healthcare availability on population outcomes for older adults. This work is separated into two interconnected components. First, I study the factors associated with local service availability. Second, I seek to advance science by employing quasi-experimental studies that use ‘disruptions’ to evaluate how a change in healthcare availability affects outcomes. The primary scientific methods I use are secondary analysis of large existing databases focused on Medicare claims (including novel linkages across different types of data) and geospatial information system (GIS) methods.
