Research Interest

I conduct mixed-method studies that use innovative technologies to examine the relationship between gender and health behaviors. My funded research started in Detroit, Michigan, USA (e.g., female heroin and T's & Blues users) and Poland (e.g., mothers and daughters) and always focuses on vulnerable populations that generally are difficult to sample (e.g., women crack smokers, prisoners, low-literate women in rural Africa).

Since 1990 I have: (1) used web-based methods to survey adolescent and young adult's substance use/abuse behaviors; (2) conducted community-based research in the Flint and Detroit, Michigan, USA areas; (3) collected data with mobile phones from low-literate women in Liberia; (4) conducted secondary analysis of pre-existing national databases (e.g., NESARC,

PATH, and MTF) focusing on LGBT, adolescent, and emerging adult populations and their mental health and substance use; and (5) used mixed-method study designs to better understand (a) adolescent prescription drug adherence and abuse, (b) the efficacy of clinical interventions to increase medication adherence in high risk populations, and (c) maternity waiting homes as an intervention to reduce maternal mortality in sub-Saharan Africa.

International experience: I have conducted research studies and research development, mentored staff, or taught courses in China (Beijing, Shanghai), Ghana, Jamaica, Liberia, Poland, and Zambia.
