It is valid for two years.

Hepatitis B		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - The Hepatitis B vaccine is a series of three doses and proof must include the dates of the first, second, and third doses of the vaccine OR a lab report for a positive Hepatitis B titer. - In the event of being considered, a "non-converter" please contact the Compliance Team at umsn-undergradcompliance@med.umich.edu for further assistance.
Requires one time submission		Complio/American DataBank document <u>uploading window</u> : Deadline for Approval		Special Instructions before uploading information to Complio/American DataBank
COVID-19 Vaccine documentation		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - It is required that you upload the following information in your Complio account: - Covid card including primary vaccine series and booster dose or - Covid card including primary vaccine series if not yet eligible for booster dose (will be considered compliant if not yet eligible) - Once eligible for booster, reupload covid card with booster information - Please email umsn-undergradcompliance@med.umich.edu with any questions.
MMR (Measels, Mumps and Rubella)		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - The MMR vaccine is two doses and proof must include the dates of the first and second doses of the vaccine after 12 months of age OR a lab report for a positive antibody titer for each of the three components (Measles, Mumps, and Rubella).
Chicken Pox (Varicella Zoster)		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - The chicken pox vaccine is two doses and proof must include the date of the first and second doses of the vaccine OR a lab report for a positive Varicella titer.
Tdap (Tetanus, Diphtheria and Pertussis)		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - Documentation of a Tdap vaccine at age 11 or after is required. - Since Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term of enrollment or at some point during your enrollment. - Student must ensure that this requirement is valid for the entire academic year.
Criminal Background Check		April 20,2022	September 30, 2022	<ul style="list-style-type: none"> - A criminal background check must be completed through Complio/American DataBank. See Complio/American DataBank link below information under the area "How to set up your Complio Account".
