Flu (Influenza) vaccine	August 15, 2021	August 15, 2021	November 29, 2021	<ul style="list-style-type: none"> - Flu shots will be available on campus at the end of September or beginning of October. - You may receive your vaccine anytime during the acceptance period at a location of your choice. - Instructions detailing when the flu shots will be available and how to provide proof of compliance will be sent each fall. - The school of nursing form is optional.

It is valid for two years.

COVID-19 Vaccine documentation		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - It is not mandatory that you receive the vaccine, however, we are requiring that you complete the following information in your Complio account: - Answer question with yes or no if you have received the vaccine - If vaccine was received, include the following: Date received, Manufacturer, Lot #, UMID ID, UMICH Email. - Please email umsn-undergradcompliance@med.umich.edu with any questions.
MMR (Measles, Mumps and Rubella)		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - The MMR vaccine is two doses and proof must include the dates of the first and second doses of the vaccine after 12 months of age OR a lab report for a positive antibody titer for each of the three components (Measles, Mumps, and Rubella).
Chicken Pox (Varicella Zoster)		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - The chicken pox vaccine is two doses and proof must include the date of the first and second doses of the vaccine OR a lab report for a positive Varicella titer.
Tdap (Tetanus, Diphtheria and Pertussis)		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - Documentation of a Tdap vaccine at age 11 or after is required. - Since Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term of enrollment or at some point during your enrollment. - Student must ensure that this requirement is valid for the entire academic year.
Criminal Background Check		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - A criminal background check must be completed through Complio/American DataBank. See Complio/American DataBank link below information under the area “How to set up your Complio Account”.
Handbook Certification		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - Please complete the form in its entirety or it will be rejected. This includes all of the following: student signature, printed name, date and UM ID. - The form must be uploaded.
Authorization to Disclose Information Statement		April 22, 2021	September 30, 2021	<ul style="list-style-type: none"> - Please complete the form in its entirety or it will be rejected. This includes all of the following: First and Last Name, phone #, unickname and UM ID, in addition please complete the authorization to disclose area by completing all of the following: both boxes must be checked, enter first and last name, sign and date. - Both pages of the form must be uploaded for acceptance.
