Flu (Influenza) vaccine	August 15, 2025	August 15, 2025	October 15, 2025	 Flu shots will be available on campus at the end of September or beginning of October. You may receive your vaccine anytime during the acceptance period at a location of your choice. Instructions detailing when the flu shots will be available and how to provide proof of compliance will be sent each fall. The school of nursing form is optional. This is a yearly requirement
Hepatitis B		April 23, 2025	September 30, 2025	 The Hepatitis B vaccine is a series of three doses and proof must include the dates of the first, second, and third doses of the vaccine OR a lab report for a positive Hepatitis B titer. In the event of being considered a "non-converter" please contact the Compliance Team at umsn-undergradcompliance@med.u mich.edu for further assistance. This is a one-time requirement

MMR (Measles, Mumps and Rubella) one-time		April 23, 2025	September 30, 2025	 The MMR vaccine is two doses and proof must include the dates of the first and second doses of the vaccine after 12 months of age OR a lab report for a positive antibody titer for each of the three components (Measles, Mumps, and Rubella). This is a one-time requirement
Chicken Pox (Varicella Zoster) one-time		April 23, 2025	September 30, 2025	 The chicken pox vaccine is two doses and proof must include the date of the first and second doses of the vaccine OR a lab report for a positive Varicella titer. This is a one-time requirement
Tdap (Tetanus, Diphtheria & Pertussis)		April 23, 2025	September 30, 2025	 Documentation of a Tdap vaccine at age 11 or after is required. Since Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term of enrollment or at some point during your enrollment. Students must ensure that this requirement is valid for the entire academic year.
CPR, Criminal Background Check and Drug Screening	Earliest date requirement can be administered			Special Instructions before uploading information to Complio/American DataBank
CPR (Cardiopulmonary Resuscitation) Certification	April 23, 2025	April 23, 2025	September 30, 2025	 We only accept the American Heart Association BLS for Healthcare provider's course, an American Red Cross CPR course completed will not be accepted. Please upload your proof of completion. It is valid for two years. This requirement is needed every two years
Criminal Background Check		April 23, 2025	September 30, 2025	- A criminal background check must be completed through Complio/American DataBank. See Complio/American DataBank link below information under the area "How to set up your Complio Account". - This is a one-time requirement

Drug Screen	- DO NOT ORDER YOUR DRUG SCREEN UNTIL INSTRUCTED TO DO SO BY YOUR SCHOOL. You must order a drug screen through your Complio account only. No other tests will be accepted. More information regarding drug testing will be announced during the student's school of nursing orientation.
