<u><a href="#">TB skin test (also called TB or PPD) or blood test</a></u>  <b>Important Notice: In order to ensure an accurate test result, <u>do not schedule a TB test within four weeks of a Covid-19 Immunization</u></b>	April 23, 2025	April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- Documentation must include the date administered, the date read and negative results OR a lab report showing a negative QuantiFERON TB Gold or T-SPOT blood test and test date</li> <li>- Blood tests are valid for three years</li> <li>- In the event of a positive result, please contact the Compliance Team at <a href="mailto:umsn-undergradcompliance@med.umich.edu">umsn-undergradcompliance@med.umich.edu</a> for further assistance.</li> <li>- The school of nursing form is optional</li> <li>- <b>this is a yearly requirement</b></li> </ul>
<u><a href="#">Flu (Influenza) vaccine</a></u>	August 15, 2025	August 15, 2025	October 15, 2025	<ul style="list-style-type: none"> <li>- Flu shots will be available on campus at the end of September or beginning of October.</li> <li>- You may receive your vaccine anytime during the acceptance period at a location of your choice.</li> <li>- Instructions detailing when the flu shots will be available and how to provide proof of compliance will be sent each fall.</li> <li>- The school of nursing form is optional.</li> <li>- <b>this is a yearly requirement</b></li> </ul>
Hepatitis B		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- The Hepatitis B vaccine is a series of three doses and proof must include the dates of the first, second, and third doses of the vaccine OR a lab report for a positive Hepatitis B titer.</li> <li>- In the event of being considered a “non-converter” please contact the Compliance Team at <a href="mailto:umsn-undergradcompliance@med.umich.edu">umsn-undergradcompliance@med.umich.edu</a> for further assistance.</li> <li>- <b>this is a one-time requirement</b></li> </ul>
MMR (Measles, Mumps and Rubella)		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- The MMR vaccine is two doses and proof must include the dates of the first and second doses of the vaccine after 12 months of age OR a lab report for a positive antibody titer for each of the three components (Measles, Mumps, and Rubella).</li> <li>- <b>this is a one-time requirement</b></li> </ul>

Chicken Pox (Varicella Zoster)		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- The chicken pox vaccine is two doses and proof must include the date of the first and second doses of the vaccine OR a lab report for a positive Varicella titer.</li> <li>- <b>this is a one-time requirement</b></li> </ul>
Tdap (Tetanus, Diphtheria & Pertussis)		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- Documentation of a Tdap vaccine at age 11 or after is required.</li> <li>- Students must ensure that this requirement is valid for the entire academic year.</li> <li>- <b><u>Since Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term of enrollment or at some point during your enrollment.</u></b></li> </ul>

<u>CPR</u> (Cardiopulmonary Resuscitation) Certification	April 23, 2025	April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- We only accept the American Heart Association BLS for Healthcare provider's course, an American Red Cross CPR course completed <b><u>will not be accepted.</u></b></li> <li>- Please upload your proof of completion. It is valid for two years.</li> <li>- <b>this requirement is needed every two years</b></li> </ul>
Criminal Background Check		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> <li>- A criminal background check must be completed through Complio/American DataBank. See Complio/American DataBank link below for information on "How to set up your Complio Account".</li> <li>- <b>this is a one-time requirement</b></li> </ul>
Drug Screen				<ul style="list-style-type: none"> <li>- <b>DO NOT ORDER YOUR DRUG SCREEN UNTIL INSTRUCTED TO DO SO BY YOUR SCHOOL. <u>You must order a drug screen through your Complio account only. No other tests will be accepted.</u></b> More information regarding drug testing will be announced during the student's school of nursing orientation.</li> <li>- <b>this is a yearly requirement</b></li> </ul>
