## 2019-2020 UNDERGRADUATE STUDENT COMPLIANCE REQUIREMENTS

The University of Michigan School of Nursing Compliance Policy requires all School of Nursing students taking any course to be in full compliance, regardless of the course. This includes courses without a clinical component.

Compliance documents are managed by a third party vendor, CastleBranch <u>www.castlebranch.com</u>. All students must create an online account and upload all compliance documents into the online account. Undergraduate students should use package code UB58 to order a background check and a new account.

All compliance documents are due on **July 1** each year to avoid a compliance fee with the exception of the flu vaccine requirement. Flu vaccines are due on November 22 for the 2019-2020 academic year to avoid a compliance fee. In order for requirements to be valid for the entire academic year 2019-2020, no compliance documents shall expire before the last day of classes in April, which is April 21, 2020. 	In order for the document to be valid for the entire 2019-2020 academic year, the document must be <u>completed on or after April 22, 2019.</u> Please note <u>both pages</u> must be uploaded.
Cardiopulmonary Resuscitation Certification (CPR)  Tuberculin Skin Test (also called TB or PPD) or blood test	<b>ONLY</b> the <u>American Heart Association BLS for Healthcare provider's course is accepted</u> . It is valid for two years.
	An official digital certificate of completion must be uploaded to CastleBranch.
	In order for the document to be valid for the entire 2019-2020 academic year, the document must be <i>completed on or after April 22, 2019.</i>
	Complete documentation must be uploaded to CastleBranch and includes the date that a TB skin test was administered, the date that it was read, and negative results <b>OR</b> a lab report showing a negative QuanitiFERON TB Gold or T-SPOT blood test and test date. Blood tests are valid for three years.

Hepatitis B	The Hepatitis B vaccine is a series of three doses.	
	Complete documentation must be uploaded to CastleBranch and includes the dates of the first, second, and third doses of the vaccine <b>OR</b> a lab report for a positive Hepatitis B titer.

MMR (Measles, Mumps, and Rubella)	The MMR vaccine is two doses.	
	Complete documentation must be uploaded to CastleBranch and includes the dates of the first and second doses of the vaccine after 12 months of age <b>OR</b> a lab report for a positive antibody titer for each of the three components (Measles, Mumps, and Rubella).	
Varicella Zoster (Chicken Pox)	The chicken pox vaccine is two doses.	
	Complete documentation must be uploaded to CastleBranch and includes the date of the first and second doses of the vaccine <b>OR</b> a lab report for a positive Varicella titer.	
Tdap (Tetanus, Diphtheria, and Pertussis)	Documentation of a Tdap vaccine at age 11 or after is required.	
	Because Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term or enrollment or at some point during your enrollment.	
Criminal Background Check	A criminal background check must be completed through CastleBranch at <a href="https://www.castlebranch.com">www.castlebranch.com</a> . This background check is included as part of the UB58 package.	
Handbook Certification	The signed form must be uploaded to CastleBranch.	
Authorization to Disclose Information Statement	Both pages of the signed form must be uploaded to CastleBranch.	
DUE EVERY FALL PRIOR TO THE STATED DEADLINE FOR THE ACADEMIC YEAR		
Flu Shot	Flu shots will be available on campus at the end of September or beginning of October.	
	Instructions detailing when the flu shots will be available and how to provide proof of compliance with this requirement will be sent every fall.	
	The administered date must be between August 15, 2019 and November 22, 2019 to be accepted for the 2019-2020 academic year.
