Please also complete the acknowledgement of receipt area including: First Name, Last Name, Signature and Date. <u>If you are not living in a state other than Michigan during the course of your Undergraduate program,</u> you only need to complete the acknowledgement of receipt area including: First Name, Last Name, Signature and Date. - This form must be uploaded to Complio - this is a yearly requirement

TB skin test (also called TB or PPD) or blood test Important Notice: In order to ensure an accurate test result, <u>do not schedule a TB test within four weeks of a Covid-19 Immunization</u>	April 23, 2025	April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> - Documentation must include the date administered, the date read and negative results OR a lab report showing a negative QuantiFERON TB Gold or T-SPOT blood test and test date - Blood tests are valid for three years - In the event of a positive result, please contact the Compliance Team at umsn-undergradcompliance@med.umich.edu for further assistance. - The school of nursing form is optional - This is a yearly requirement
Flu (Influenza) vaccine	August 15, 2025	August 15, 2025	October 15, 2025	<ul style="list-style-type: none"> - Flu shots will be available on campus at the end of September or beginning of October. - You may receive your vaccine anytime during the acceptance period at a location of your choice. - Instructions detailing when the flu shots will be available and how to provide proof of compliance will be sent each fall. - The school of nursing form is optional. - This is a yearly requirement
Tdap (Tetanus, Diphtheria & Pertussis)		April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> - Documentation of a Tdap vaccine at age 11 or after is required. - <u>Since Tdap vaccines are only valid for ten years, you may need to receive a Td booster prior to your first term of enrollment or at some point during your enrollment.</u> <ul style="list-style-type: none"> - Students must ensure that this requirement is valid for the entire academic year.

CPR (Cardiopulmonary Resuscitation) Certification	April 23, 2025	April 23, 2025	September 30, 2025	<ul style="list-style-type: none"> - We only accept the American Heart Association BLS for Healthcare provider's course, an American Red Cross CPR course completed <u>will not be accepted.</u> - Please upload your proof of completion. It is valid for two years. - This requirement is needed every two years
Drug Screen				<ul style="list-style-type: none"> - DO NOT ORDER YOUR DRUG SCREEN UNTIL INSTRUCTED TO DO SO BY YOUR SCHOOL. You must order a drug screen through your Complio account only. No other tests will be accepted. More information regarding drug testing will be announced during the student's school of nursing orientation. - This is a yearly requirement
